Sub: Request for provide support for living and compensations to families of the dead and lostfishermen from Kakdwip, West Bengal due to accident off the Beyporeharbour in Kerala.

Sir,

You must have been informed thata fishing boat namely F.B. RABANwent to fish in the sea from Beypore Fishing Harbour of Kerala on 11.04.2021. A shipcollided with the said fishing boat and sank it. Somefishing crew members of theboat were migrant fishers. They migrated from Kakdwip area of the State of WestBengal. It has been reported that among the fishing crew members of the capsizedfishing boat the dead bodies of the following have been recovered -

1. Paban Das (Aadhaar No. 5896 5430 2499 & Home Contact Mob.7501267644), of Village -Dakshin Pukurberia of Kakdwip of District South 24Parganas of the State of West Bengal.
2. Subal Das (Aadhaar No. 4357 7356 5800& Home Contact Mob.6295835415), of Village- ProsadpurofofKakdwip of P.S.- H.P. Coastal of DistrictSouth 24 Parganas of the State of West Bengal, and
3. Subal Das (Aadhaar No. 5246 2425 9344& Home Contact Mob.8116589187), Son of Jamini Das, of Village- Daserchak of Kakdwip of DistrictSouth 24 Parganas the State of West Bengal.

The following fishing crew members are still missing as per informationcollected through our organizational source till date -

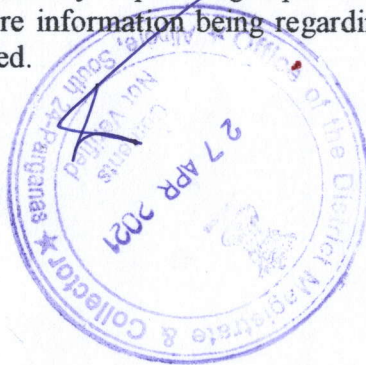
