Sub: Request for providing compensations to the families of deceased fishermen and taking effective steps to rescue the missing crews of the fishing boat capsized due to collision by a ship.

Respected Sir,

This is to bring to your kind notice that a fishing boat namely F.B. RABAN went to fish in the sea from Beypore Fishing Harbour on 11.04.2021. A ship collided with the said fishing boat and sank it. Some fishing crew members of the boat were migrant fishers. They migrated from Kakdwip area of the State of West Bengal. It has been reported that among the fishing crew members of the capsized fishing boat the dead bodies of the following have been recovered –

1. Paban Das (Aadhaar No. 5896 5430 2499 & Home Contact Mob. 7501267644), of Village –Dakshin Pukurberia of Kakdwip of District South 24 Parganas of the State of West Bengal.

2. Subal Das (Aadhaar No. 4357 7356 5800& Home Contact Mob. 6295835415), of Village- Prosadpur ofofKakdwip of P.S.- H.P. Coastal of District South 24 Parganas of the State of West Bengal, and

3. Subal Das (Aadhaar No. 5246 2425 9344& Home Contact Mob. 8116589187), Son of Jamini Das, of Village- Daserchak of Kakdwip of District South 24 Parganas the State of West Bengal.

The following fishing crew members are still missing as per information collected through our organizational source till date –

1. Manik Das (Aadhaar No. 3774 0230 2745 & Home Contact Mob. 8250755316), Village – Dakshin Gobindapur of Kakdwip of District South 24 Parganas of the State of West Bengal.
